

ORDINANCE NO. 340

AN ORDINANCE OF THE TOWNSHIP OF ANTRIM,  
FRANKLIN COUNTY, PENNSYLVANIA  
PROHIBITING PARKING AND ESTABLISHING A TOW AWAY ZONE  
ALONG ANTRIM COMMONS DRIVE

**WHEREAS**, Section 1527 of the Second Class Township Code, as amended, (53 P.S. 66527) authorizes the Board of Supervisors of Second Class Townships to adopt ordinances to secure the safety of persons or property within the Townships; and

**WHEREAS**, Section 2328 of the Second Class Township Code, as amended, (53 P.S. 67328) authorizes the Board of supervisors of Second Class Townships to adopt ordinances regulating parking and further authorizes the imposition of penalties for violations of the parking regulations; and

**WHEREAS**, the Pennsylvania Vehicle Code authorizes local authorities on streets or highways within their physical boundaries to regulate or prohibit stopping standing or parking (75 Pa. C.S.A. §6109; and

**WHEREAS**, the Vehicle Code provides that local authorities may exercise the powers granted in the code only by duly enacted ordinances of their governing bodies (75 Pa. C.S.A §6102-b); and

**WHEREAS**, A traffic study has been prepared for Antrim Commons Drive; and

**WHEREAS**, said study indicated that the traffic regulations as set forth in this ordinance should be enacted.

**NOW THEREFORE, BE IT ENACTED AND ORDAINED**, by the Board of Supervisors of the Township of Antrim, Franklin County, Pennsylvania, pursuant to the authority as described above and in accordance with the Traffic Study in Exhibit A attached hereto and incorporated herein by reference, that the Code of The Township of Antrim shall be amended in the following manner.

**Section 1:** Chapter 139-29 entitled "Parking prohibited at all times in certain locations." shall be amended by the addition of the following inserted in alphabetical order:

<u>Street</u>	<u>Side</u>	<u>Location</u>
Antrim Commons Drive	Both and around cul-de-sac	From Rt. 11 West to the Cul-de-sac

**Section 2:** Chapter 139-38 entitled "Tow-away zones designated." shall be amended by the addition of the following inserted in alphabetical order:

<u>Street</u>	<u>Side</u>	<u>Location</u>
Antrim Commons Drive	Both and around cul-de-sac	From Rt. 11 West to the Cul-de-sac

**Section 3:** The penalties for violating this ordinance shall be as set forth in the Pennsylvania Vehicle Code, as amended.


**Section 4:** The provisions of this ordinance shall be severable, and if any of its provisions shall be held to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect the remaining provisions of this ordinance.

**Section 5:** All other ordinances or parts of ordinances inconsistent herewith are hereby repealed.


**Section 6:** This ordinance shall take effect in accordance with the law.


