

**ANTRIM TOWNSHIP MUNICIPAL AUTHORITY**  
**REGULAR MEETING OF JULY 28, 2008**

The Antrim Township Municipal Authority met Monday, July 28, 2008, at 7 p.m., in the Antrim Township Municipal Building with the following members in attendance: Elwood Myers, Roy Baum and Robert Schemmerling. Rodney Eberly was absent at this time and B.J. Roberts had submitted a letter of resignation. Also attending were Thomas Steiger Jr., was in attendance in the absence of Shawn Meyers, Solicitor; Charles Goetz Jr., Director of Public Utilities; Larson Wenger, Utilities Superintendent; and Dave Brinjac of Brinjac Engineering.

Audience members included Bob Coladonato.

Chairman Myers called the meeting to order at 7:00 p.m.

It was noted that the meeting was being tape recorded.

On a Baum/Schemmerling motion, passed 3-0, the meeting minutes of June 30, 2008 were approved. (Eberly was absent from the meeting.)

On a Schemmerling/Baum motion, passed 3-0, (Eberly was absent from the meeting), the Treasurer's Report for Water was approved along with the payment of bills with a request from Schemmerling that the payroll item in the Treasurer's report be broken down and kept in the previous format.

On a Baum/Schemmerling motion, passed 3-0, (Eberly was absent from the meeting), a sewer planning module for Myers/Yaukey, subdivision plan, Patton Bridge Road, was denied as it was deemed incomplete.

On a Schemmerling/Baum motion, passed 3-0, (Eberly was absent from the meeting), a sewer planning module for Thomas Statler, Guitner Road, 1-lot on-lot septic, was approved.

On a Baum/Schemmerling motion, passed 3-0, (Eberly was absent from the meeting), a sewer planning module for Diller, Molly Pitcher Highway South, was approved assessed at 1 Equivalent Dwelling Unit.

Authority members recognized the following two plans: William Webster, 6-lot subdivision with on-lot septic and Thomas Statler, Guitner Road, 1-lot subdivision plan with on-lot septic.

On a Baum/Roberts motion, passed 5-0, the following subdivision plans were recognized as having on-lot systems or as being lot additions:
