Minutes of the Antrim Township Supervisors Regular Meeting

The Antrim Township Board of Supervisors met Tuesday, January 26, 2021 at the Antrim Township Municipal Building, located at 10655 Antrim Church Road, with the following members present: John Alleman, Chairman; Rick Baer, Vice Chairman; Fred Young, Pat Heraty and Chad Murray. Also attending was: John Lisko, Solicitor; Rodney Eberly, Roadmaster; Brad Graham, Administrator; and Jennifer Becknell, Secretary/Treasurer.

Alleman called the meeting to order at 7:02 p.m.

Alleman commented that meetings are audio recorded and posted to the Township website.

Young announced that Bill McLaughlin, affiliated with the Borough of Chambersburg, passed away. Young praised Mr. McLaughlin for his work on economic development in the area and asked for a moment of silence in remembrance.

A Heraty/Young motion passed 5-0 denying relief from sewer utility billing for 12903 Williamsport Pike, following the same recommendation from the Antrim Township Municipal Authority given at their January 25, 2021 meeting.

Alleman stated that the road crew must have done a good job on clearing the roads as he received no complaint phone calls.

Alleman called for Public Comments. There were none.

A Heraty/Young motion passed 5-0 to adjourn the Regular Meeting, into Executive Session, at 7:20 p.m. to discuss a personnel matter and potential litigation.
