

**AN ORDINANCE OF ANTRIM TOWNSHIP,
FRANKLIN COUNTY, PENNSYLVANIA, NO. 349 OF 2016**

**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF
ANTRIM, FRANKLIN COUNTY, PENNSYLVANIA, AMENDING CHAPTER 111
ENTITLED "PRETREATMENT".**

WHEREAS, the Township of Antrim currently has pretreatment regulations as set forth in the Code of the Township of Antrim, Pennsylvania; and

WHEREAS, the Antrim Township Board of Supervisors desire to amend the Code of the Township of Antrim in order to comply with State and Federal Laws and Regulations; and

WHEREAS, the amendment of Chapter 111 of the Code of the Township of Antrim is necessary to assure continuity of wastewater treatment, help prevent violation of the Authority's NPDES permit and protect the system from damage; and

WHEREAS, the amendment of Chapter 111 of the Code of the Township of Antrim is necessary for the protection, benefit and preservation of the health, safety and welfare of the inhabitants of the Township; and

WHEREAS, authority is vested in the Township of Antrim to require connection to and establish rules and regulations for sewer systems within the Township by Section 2501 et seq. of the Second Class Township Code (53 P.S. 67501 et seq.) and other State and Federal Laws.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, by the Board of Supervisors of the Township of Antrim as follows:

SECTION I: The Code of the Township of Antrim, Franklin County, Pennsylvania Chapter 111-4 entitled "Definitions" is hereby amended by adding the following definitions in alphabetical order:

CONTROL AUTHORITY – Antrim Township

NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT – A permit issued to control the discharge of pollutants from point sources into the navigable waters, the contiguous zone and the oceans pursuant to Section 402 of the Act (33 U.S.C. §1342).

SECTION II: The Code of the Township of Antrim, Franklin County, Pennsylvania Chapter 111-4 entitled "Definitions" is hereby amended by deleting the following definitions in their entirety and adding them as follows:

EQUIVALENT DWELLING UNIT (EDU) -- That part of a residential or Nonresidential Establishment with flows equal to 251 gallons per day. (Amended by Resolution # 263 May 13, 2014)

SIGNIFICANT NONCOMPLIANCE or SNC -- An IU that has violated Pretreatment Standards and /or Pretreatment Requirements and such violation(s) meet one or more of the criteria set forth in Article IX of this Chapter and in 40 CFR §403.8(f)(2)(viii).

SECTION III: The Code of the Township of Antrim, Franklin County, Pennsylvania Chapter 111-8 entitled "Local Limits" is hereby amended by deleting subsection B in its entirety and replacing it with

the following new subsection B. Schedule A is attached hereto and incorporated herein by reference. New subsection B shall read as follows:

- B. Local Limits for pollutants of concern, as set forth in the attached Schedule A, the same being incorporated herein by this reference, shall be amended after EPA approval by ordinance of the Township of Antrim to protect against Pass Through and Interference, and to protect the sludge quality. Local Limits may be allocated on an individual basis to the Industrial Users and defined through Wastewater Discharge Permits issued pursuant to Article IV and Article V of this Ordinance. The Township may continue to develop these limits as necessary and effectively enforce such limits.

SECTION IV: The Code of the Township of Antrim, Franklin County, Pennsylvania Chapter 111-13 entitled "Accidental Discharge/Slug Discharge Control Plans" is hereby amended by adding "and Safety Data Sheets;" to the end of subsection B. New subsection B shall read as follows:

- B. Description of stored chemicals and Safety Data Sheets;

SECTION V: The Code of the Township of Antrim, Franklin County, Pennsylvania Chapter 111-19 entitled "Industrial Wastewater Discharge Permit Application Contents" is hereby amended by adding "in the form prescribed by the Township" to the end of the first sentence in subsection A. All following subsections shall remain as written. The amended subsection A opening paragraph shall read as follows:

- A. All Users required to obtain an individual wastewater discharge permit must submit a permit application in the form prescribed by the Township. The Township may require Users to submit all or some of the following information as part of a permit application:

SECTION VI: The Code of the Township of Antrim, Franklin County, Pennsylvania Chapter 111-34 entitled "Periodic Compliance Reports" subsection C is hereby amended by deleting it in its entirety and replacing it with the new subsection C as follows:

- C. The Township may reduce the requirement for periodic compliance reports [see Section 111.34(A) (40 CFR 403.12(e)(1))] to a requirement to report no less frequently than once a year, unless required more frequently in the Pretreatment Standard or by the EPA, where the Categorical Industrial User's total categorical wastewater flow does not exceed any of the following:
 - 1. Greater than 0.01 percent of the POTW's design dry-weather hydraulic capacity of the POTW treatment plant, or 5,000 GPD, whichever is smaller, as measured by a continuous effluent flow monitoring device unless the Industrial User discharges in batches;
 - 2. Greater than 0.01 percent of the POTW's design dry-weather organic capacity of the POTW treatment plant; and
 - 3. Greater than 0.01 percent of the maximum allowable headworks loading for any pollutant regulated by the applicable Federal Categorical Pretreatment Standard for which approved Local Limits are developed, in accordance with §111.8 of this Ordinance.

Reduced reporting is not available to Industrial Users that have in the last two (2) years been in Significant Noncompliance, as defined in Article IX of this Chapter. In addition, reduced reporting is not available to an Industrial User with daily flow rates, production levels, or pollutant levels that vary so significantly that, in the opinion of the Township, decreasing the

reporting requirement for this Industrial User would result in data that are not representative of conditions occurring during the reporting period.

SECTION VII: Effective Date. This Ordinance shall be in full force and effect immediately following its passage, approval, and publication, in accordance with the law.

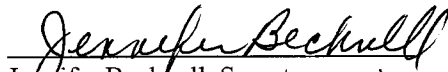
SECTION VIII: Conflict with other Township Regulations. All other Township regulations as set forth in the Code of the Township of Antrim are hereby repealed if their requirements are less stringent than the requirements as set forth in this ordinance. However, if the requirements are more stringent than the requirements as set forth in this ordinance, then they shall continue in full force and effect. In other words, the more stringent requirement shall apply.

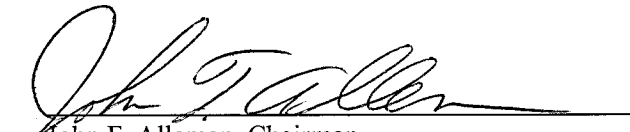

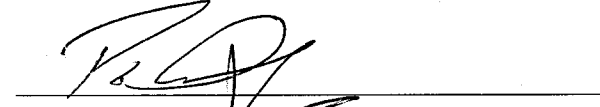
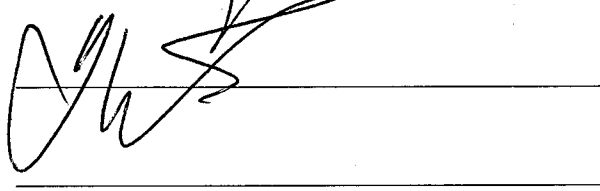

Schedule A
Antrim Township Local Limits

The following Maximum Allowable Industrial Loadings (MAILs) are developed to protect against pass through and interference, and to protect sludge quality. Individual limitations may be allocated to the Industrial Users as needed through Wastewater Discharge Permits issued to the Industrial Users in accordance with Article IV and Article V of Ordinance 311 of 2008. The following Daily Maximum MAIL limits apply at the point where the wastewater is discharged to the POTW.
