### **SECTION I**

#### THE USER AGREES TO THE FOLLOWING REQUIREMENTS:

- A. The Tournament organizer shall be responsible for keeping the facilities in clean and original condition. This would include picking up trash around the ballpark and fields, emptying trash cans and placing trash in dumpster, replacing trash bags, cleaning and maintaining the restrooms during and immediately after the use of the facilities and restroing the facilities to their conditions prior to use. Trash bags and restroom supplies will be provided.
- B. The Tournament organizer shall hire its own umpires and maintenance staff to maintain the fields, keeping it in a safe and playable condition. Fields <u>must</u> be left in playable condition.
- C. The Tournament organizer shall be responsible for participant and spectator supervision and conduct.
- D. The Tournament organizer shall be responsible for keeping spectators and participants from parking on the grass and setting on or blocking the walking paths at the park.
- E. The Tournament organizer shall be responsible for keeping spectators and participants out of the pavilions unless pavilions are rented by Tournament organizer. If pavilions are rented, renters have the pavilion for the whole day and can NOT be occupied by another party.
- F. **NO Alcohol** is allowed on park property.
- G. No pitching or hitting against fences and sheds.
- H. Antrim Township Community Park is a <u>Tobacco and Smoke and Vape Free</u> facility. Patrons wishing to indulge in tobacco or vaping products must do so off park premises.
- I. The Tournament organizer will comply with all Ordinances, rules and regulations of the Antrim Township Community Park and Antrim Township affecting the use of this facility. It is the responsibility of the Tournament organizer to make themselves aware of any such Ordinances, rules and regulations. (Ordinances are posted on the Township website) Tournament organizers are responsible for making all attendees aware also.
- J. All tournaments at Antrim Township Community Park will be conducted between the operating hours of the park from 8:00 a.m. to dusk. All users must vacate park at dusk.
- K. Antrim Township reserves the right to deny any signage on the park grounds. Any tournament organization wishing to display signage of their organization or of their sponsors must first get permission to display signage and must display any signage in designated areas only.

#### **SECTION II**

### **Field Reservation and Rental:**

- A. A non-refundable reservation fee of \$45 per day per field is required to reserve the date.
- B. Reservation fee will be credited towards game fees.
- C. Game fee is \$30.00 per game (minimum of 3 games per field).
- D. A Certificate of Liability Insurance in the amount of \$1,000,000/\$3,000,000 general liability, \$1,000,000, property damage naming Antrim Township as additional insured. A current liability insurance certificate will be due prior to approval.

#### **SECTION III**

## **Rainouts/ Cancellations:**

- A. Multi day cancellations are rare due to rainouts. The Parks Director will approve refunds on a case-by-case basis.
- B. Antrim Township reserves the right to cancel field reservations or suspend play due to severe weather or unsafe playing conditions. The Parks Director will approve refunds on a case-by-case basis
- C. Antrim Township reserves the right to cancel for unforeseen circumstances that effect the ability to provide a safe playing environment. Reservation fees will be refunded.

#### **SECTION IV**

#### Payment:

- A. Payment is due on the 30th of each month for the dates used from the previous month.
- B. With payment, please provide a bracket of # of games played for each event.
- C. Fee is \$30.00 per game less the reservation fee.

#### SECTION V

Any abuse or damage to Antrim Township Community Park that is not normal wear and tear for tournament usage, will be the sole responsibility of the tournament organizer and/or the sanctioning organization of the tournament.

Documentation of any occurrences will be made, and responsible parties will be notified for reimbursement. If the responsible parties do not comply with paying for damages their organization will not be allowed back into Antrim Township Community Park until the situation is resolved and will forfeit any future secured dates at the park. Further legal action may result depending on the severity of the occurrence.

#### **SECTION VI**

The Tournament organizer shall indemnify and hold harmless Antrim Township against any and all expense liabilities and claims of every kind by and on behalf of any person or entity arising out of the conduct or action of the tournament organizer, its employees, agents or participants in any event sponsored by the tournament director.
