REQUEST FOR PLANNING WAIVER / NON-BUILDING DECLARATION SHALL INCLUDE THE FOLLOWING:

- ☐ 1 – Copy of the Request for Planning Waiver/ Non-building Declaration. Each RFPW-NBD shall be accompanied with a plot plan.

If submitting a subdivision or land development plan with prior approved sewage planning, you must indicate when and with what plan prior planning was approved and provide a duplicate copy of the DEP approval letter.

If any of these items are incomplete, missing, or not on the correct form the Township is still required to submit them according to Title 25 of the Commonwealth of the Pennsylvania, and DEP will review as submitted.
